

2013 Annual Report

Agency Activities

In 2013, the Hayden Urban Renewal Agency conducted the following activities:

- Adopted the annual budget and fund balance policy
- Researched and invested funds
- Researched the real estate market, explored purchase and sale of various properties
- Participated in regional and State legislative discussions
- Participated in the Redevelopment Association of Idaho
- Partnered with the City of Hayden Arts Commission on projects
- Purchased blighted property located at Hayden Avenue and Government Way and entered into a Disposition and Development Agreement for re-development into a public/private parking lot
- Entered in a parking lot construction and lease agreement with the City of Hayden for property located adjacent to City Hall; said property to be developed as a key parking lot to facilitate downtown development and assist in providing for parking reductions for commercial properties located in the downtown.



Revenues & Expenditures

In 2013, the District received \$559.218 in property taxes and made \$5,815 in investment earnings. The Agency assets, comprised of interest bearing investments and land, were valued at approximately \$1.8 million. In 2012, assets were valued at approximately \$1.4 million. 2013 routine expenditures were similar to 2012 expenditures and were primarily related to Arts Commission projects, the annual audit, insurance, and staff/legal support services. Additionally in 2013, the Agency purchased property for a public/private rehabilitation project and had costs related to the purchase as well as the administrative costs related to creation and administration of a disposition and development agreement. The Agency also had administrative and legal costs related to the development of lease and construction agreements for the City Hall parking lot reconstruction project.
